PRE-REQUISITES

For participants who intend to become Competent MASHRAE i-Commissioning Specialists, there are a number of pre-requisites. You must:

1. Attend at least 75% of the iCxS Competency course, **AND**
2. Pass the iCxS Examination.

You must also possess one of the following qualifications:

1. Is a technical personnel with at least 10 years relevant experience in design office and field commissioning works, and has obtained certification from other MASHRAE recognised training programmes such as TABB certified supervisor, ASHRAE, NEBB, ACG, BCxA and CSA; **OR**
2. Is an engineer registered with BEM or a registered architect with LAM, with more than 5 years of testing and commissioning experience in building services, **OR**
3. Is a competent electrical engineer or supervising engineer registered with Suruhanjaya Tenaga.

EXAMINATION

The examination comprises a 2-hour multiple choice question paper and an individual project assignment & presentation.

Only participants who intend to become Competent MASHRAE iCxS are required to sit for the examination.

Upon passing the examination, you may then apply to be registered as a Competent MASHRAE iCxS. (Existing registered GBI CxS may apply to register as MASHRAE iCxS on a case-to-case basis without the need to attend and pass the MASHRAE iCxS examination).
